**Every entry at a recognized show shall constitute an agreement and affirmation that the person making it, along with the owner, lessee, trainer, manager, coach, rider, and the horse:**

- Shall be subject to the by-laws and rules of MHSA and the local rules of the show. Riders competing in classes restricted to amateurs must meet the requirements of USEF rule GR1306. Your signature as rider on this entry blank will verify that you understand and are in compliance with this rule.
- That every horse and rider is eligible as entered.
- That the owner and any of his/her representatives are bound by the by-laws and rules of MHSA, and BEST Horse Shows LLC, and will accept as final the decision of the Enforcement Committee on any questions arising under said rules and agree to hold the show, MHSA, and their Officials, Directors, Employees, Sponsors, and Vendors harmless for any action taken.
- That as a condition of acceptance of the entry, MHSA and the competition may use or assign photographs, videos, audios, cable-casts, or other likenesses of me and my horse taken during the course of the competition for promotion, coverage or benefit of the competition, sport, or MHSA. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or misappropriation.
- That the owner, rider and any of their agents or representatives agree to hold the MHSA, BEST Horse Shows LLC, PGEC, their Officials, Directors, Employees, Agents, Sponsors, and Vendors harmless for any injury or loss suffered during or in connection with the show, whether or not such injury or loss resulted, directly or indirectly, from the negligent acts or omissions of the said Officials, Directors, Employees, Agents, Sponsors, and Vendors of the MHSA, BEST Horse Shows LLC, or PGEC. The construction and application of MHSA rules is governed by the State of Maryland.
